Global Suicides



Data provided by World Health Organization

- One million people die by suicide worldwide each year—a million lives wasted a year in vain!
- The global suicide rate is 16 per 100,000 population.
- On average, one person dies by suicide every 40 seconds somewhere in the world, or 90 suicides every hour.

Global Suicides



Data provided by World Health Organization

- In the last 45 years global suicide rates have increased by 60% worldwide.
- Suicide is among the three leading causes of death among those aged 15-44 years in some countries,
- The second leading cause of death in the 15-29 years age group
- These figures do not include suicide attempts which are up to 20 times more frequent than completed suicide.
- Suicide worldwide is estimated to represent 1.8% of the total cause of death.

The Causes of Suicide

- Suicide is generally the lack of courage of one to face the reality of life — mistakenly thought of as an escape.
- Common problems include:
 - Depression (the root of all problems)
 - Financial Desperations—Debts, Crime, Subsistence
 - Exposure—Scandals, Shame, Guilt
 - Destructive Emotions—Betrayal, Unrequited love, Jealousy, Sorrow
 - Pride—Unable to Accept Failure or Disappointment in Life
 - Idealistic—Expects Life and the World to be Perfect
 - Physical Sufferings—Terminal Illnesses, Relentless Pains, Handicap/Disabilities
 - Lost the Will to Live
 - Innate Tendency

One who considers the present reincarnation a failure

Depression

- Over 90 percent of people who die by suicide have a mental illness at the time of their death.
- Untreated mental illness is the cause for the vast majority of suicides. Mental illness includes
 - Depression
 - Bipolar Disorder
 - Schizophrenia, and others
- The most common mental illness is depression.
- Untreated depression is the number one cause for suicide.

Innate Tendency

- Some people are 'genetically' predisposed to depression, and thus they may not appear to be undergoing any negative life experiences, yet still become depressed, and may die by suicide.
- You might have heard about some individuals who died by suicide and did not exhibit any symptoms or appear to have any serious problems. In these cases, it is possible that the person had depression that occurred because of this 'genetic' factor.
- Esoterically, this is a tendency resulting from past suicides in the individual's previous lives.

More Than One Cause

- It is very rare that someone dies by suicide because of one cause. Thus, there are usually several causes, and not just one, for suicide.
- Many people die by suicide because depression is triggered by several negative life experiences, and the person does not receive treatment – or does not receive effective treatment – for the depression.

- The death of a loved one
- A divorce, separation, or breakup of a relationship
- Losing custody of children, or feeling that a child custody decision is not fair
- A serious loss, such as a loss of a job, house, or money
- A serious illness
- A terminal illness
- A serious accident
- Chronic physical pain
- Intense emotional pain

- Loss of hope
- Being victimized (domestic violence, rape, assault, etc.)
- A loved one being victimized (child murder, child molestation, kidnapping, murder, rape, assault, etc.)
- Physical abuse
- Verbal abuse
- Sexual abuse
- Unresolved abuse (of any kind) from the past
- Feeling "trapped" in a situation perceived as negative

- Feeling that things will never "get better"
- Feeling helpless
- Serious legal problems, such as criminal prosecution or incarceration
- Feeling "taken advantage of"
- Inability to deal with a perceived "humiliating" situation
- Inability to deal with a perceived "failure"
- Alcohol abuse
- Drug abuse

- A feeling of not being accepted by family, friends, or society
- A horrible disappointment
- Feeling like one has not lived up to his or her high expectations or those of another
- Bullying (adults, as well as children, can be bullied)
- Low self-esteem

Bipolar Disorder and Suicide

- Studies have shown that 25 to 50 percent of people with bipolar disorder (manic depression) attempt suicide
- Bipolar disorder is a brain disorder that causes strong mood swings or "episodes," which include both manic episodes (also known as mania) and depressive episodes (also known as depression)

Symptoms of Manic Episodes, or Mania

- Feelings of euphoria
- An abundance of energy
- Becoming extremely active
- Becoming restless
- Inability to concentrate
- Racing thoughts
- Ideas rushing through the mind one after the other
- Talking very fast
- Quickly switching from one subject to another when talking

Symptoms of Manic Episodes, or Mania

- Extreme irritability
- Aggressive behavior
- Poor judgment
- Being confused
- Sleeping very little
- Increased sexual drive
- Abusing alcohol
- Abusing drugs
- Consuming excessive sleeping tablets
- Denying that anything is wrong

Symptoms of depressive episodes, or depression

- Feeling intense sadness
- Feeling lethargic feeling like you have no energy
- Unable to concentrate
- Sleeping too much or too little
- Eating too much or too little
- Feeling worthless
- Feeling hopeless
- Feeling helpless
- Feeling negative or pessimistic

Symptoms of depressive episodes, or depression

- Losing interest in activities that you previously enjoyed
- Crying frequently
- Withdrawing from others
- Neglecting personal appearance
- Feeling angry
- Feeling guilty
- Unable to think clearly
- Unable to make decisions

Suicide Warning Signs

- Appearing depressed or sad most of the time (untreated depression is the number one cause for suicide)
- Talking or writing about death or suicide
- Withdrawing from family and friends
- Feeling hopeless
- Feeling helpless
- Feeling strong anger or rage
- Feeling trapped like there is no way out of a situation
- Experiencing dramatic mood changes
- Abusing drugs or alcohol

Suicide Warning Signs

- Exhibiting a change in personality
- Acting impulsively
- Losing interest in most activities
- Experiencing a change in sleeping habits
- Experiencing a change in eating habits
- Performing poorly at work or in school
- Giving away prized possessions
- Writing a will
- Feeling excessive guilt or shame
- Acting recklessly

FACT People who die by suicide usually talk about it first. They are in pain and oftentimes reach out for help because they do not know what to do and have lost hope. Always take talk about suicide seriously. Always.

People who talk about wanting to die by suicide do not try to kill themselves.

People who talk about wanting to die by suicide oftentimes kill themselves.

Suicide always occurs without any warning signs.
 There are almost always warning signs.

Once people decide to die by suicide, there is nothing you can do to stop them.
 Suicide can be prevented. Most people who are suicidal do not want to die; they just want to stop their pain.

Suicide only strikes people of a certain gender, race, financial status, age, etc.

FACT Suicide can strike anyone.

RACT Most people are suicidal for a limited period of time. However, suicidal feelings can recur.

FACT The vast majority of people who are suicidal do not want to die. They are in pain, and they want to stop the pain.

Suicide Myth 12 You should never ask people who are suicidal if they are thinking about suicide or if they have thought about a method, because just talking about it will give them the idea.

AGC Asking people if they are thinking about suicide does not give them the idea for suicide. And it is important to talk about suicide with people who are suicidal because you will learn more about their mindset and intentions, and allow them to diffuse some of the tension that is causing their suicidal feelings.

When people who are suicidal feel better, they are no longer suicidal. FACT Sometimes suicidal people feel better because they have decided to die by suicide, and may feel a sense of relief that the pain will soon be over.

MYTE Young people never think about suicide, they have their entire life ahead of them.

FACT Suicide is the second leading cause of

death for young people aged 10-24. Sometimes children under 10 die by suicide.

Extracts from Letter 19 (C) Master Serapis wrote to H. S. Olcott, Letters From The Masters Of The Wisdom, Second Series

Religions generally condemn suicide, although attempts have been made to justify it under certain circumstances. JUDAISM does not permit a full Jewish burial for a person who commits suicide. This tradition has also been adopted among Christians. In BUDDHISM, self-destruction is similarly frowned upon, although some believe that it is implied in the Nikāyas that among Arhats, they may have the power to choose whether to retain their bodies or not. ISLAM similarly disapproves of suicide. Although the Qur'ān does not refer to it, several Hadiths or traditions explicitly condemn suicide. Hinduism also condemns it with the possible exception of the practice of prayopavesa, or fasting to death, which is allowed only under certain conditions.

The portion of karma selected for discharge in a particular life is known as "ripe", or *prārabda* karma. With this in view, the mental, astral and physical bodies are constructed for a particular length of life. That is one reason why suicide is such a grievous mistake: it constitutes a direct refusal to work out the karma, selected for that particular incarnation, and merely postpones the trouble, as well as generating new karma of an unpleasant nature.

Even if a man is maimed for life, he should take what opportunity he has to repair the harm, should gird up his loins and valiantly continue the struggle. Suicide would mean a return to conditions similar to those from which escape is sought, with the added bad karma of the act.

Suicide is always a mistake. It temporarily solves certain problems, but it also raises new ones; for eventually, every obligation must be met, every debt paid, every pain lived through. The Consequences What Awaits The Victim On The Other Side

The rule is, that a person who dies a natural death will remain from "a few hours to several short years" within the earth's attraction, <u>i.e.</u>, in the <u>Kama-Loka</u>. But exceptions are, in the case of suicides & those who die a violent death in general.

Hence, one of such Egos, for instance, who was destined to live - say, 80 or 90 years, but who either killed himself or was killed by some accident, let us suppose at the age of 20 — would have to pass in the Kama Loka not "a few years," but in his case 60 or 70 years, as an Elementary, or rather an "earthwalker"; since he is not, unfortunately for him, even a "shell."

They are an exception to the rule, as they have to remain within the earth's attraction, & in its atmosphere — the <u>Kama-Loka</u> — till the very last moment of what would have been the natural duration of their lives. In other words, that particular wave of life-evolution must run on to its shore.

There are again cases in which the Kāma-loka entities of "suicides" and of persons dying unnatural and accidental deaths may appear and exhibit rare intelligence, because those entities have to live in Kāma-loka for the period they would have passed on earth if those accidents had not carried them away-before the struggle between the astral and spiritual affinities commences. The causes engendered by them during earth-life are not yet ripe for fruition and they must wait their natural time. But to recall these into "mediumistic" circles is equally dangerous as in the above-mentioned cases, and for the very same reasons.

A man who is torn from physical life hurriedly while in full health and strength, whether by accident or suicide, finds himself upon the astral plane under conditions differing considerably from those which surround one who dies either from old age or from disease.

The case of men struck suddenly out of physical life by accident, suicide, murder, or sudden death in any form, differs from those of persons who pass away by failure of the life-energies through disease or old age. If they are pure and spiritually minded they are specially guarded, and sleep out happily the term of their natural life. But in other cases they remain conscious-often entangled in the final scene of earth-life for a time, and unaware that they have lost the physical body-held in whatever region they are related to by the outermost layer of the astral body: their normal Kâmalokic life does not begin until the natural web of earthlife is out-spun, and they are vividly conscious of both their astral and physical surroundings.

We are often asked how suicide affects a man's position in the other world. First of all, it must be clearly understood that suicide is a wrong thing, and no man should end his life before its natural time, unless it be in an act of heroism for the benefit of others.

Such a man throws himself, in the fullest consciousness, into the lowest and most unpleasant part of the astral world, where a good deal of suffering may be his lot. Not all suicides, be it understood, for self-murder is committed from many motives, but only such as are led up to by crime and are then committed in order to avoid the consequences.

As for the poor second victim, he has already learnt and will more fully learn that **suicide is always a mistake**, for although he is out of the physical influences, he is not free of the personal associations, such as the addiction which will be felt far more deeply than in the body, and also he knows the futility of his action and its terribly tragic effect upon his mother and other members of the family.

Motive is everything and man is punished in a case of *direct* responsibility, never otherwise. In the victim's case, the natural hour of death was anticipated accidentally, while in that of the suicide, death is brought on voluntarily and with a full and deliberate knowledge of its immediate consequences. Thus a man who causes his death in a fit of temporary insanity is not a felo de se.

The circumstances surrounding a suicide immediately after death are the same as they would be for the victim of an accident, since both of them arrive upon the astral plane with equal suddenness. But there is the enormous difference that the man who dies by accident, not expecting death, is thrown into a condition of unconsciousness and usually passes through the lowest sub-plane without knowing anything of its varied unpleasantness. The suicide, on the contrary, has acted deliberately, and is generally painfully aware of much that is horrible and repugnant to him. He cannot be saved from the sights and feelings which he has brought upon himself; but he may often be helped to understand them, and may be inspired with patience, perseverance and hope by the good offices of some kind friend.
